

Drive unearths 1,597 illegal water, sewage lines

FOLLOWING a recent Madras High Court order, the Chennai Metropolitan Water Supply and Sewerage Board (CMWSSB) is ramping up efforts to disconnect unauthorised water and sewer connections.

During a recent citywide drive, authorities have identified 1,597 unlawful connections.

A senior CMWSSB official

said, "Some residents had encroached water bodies and public land and secured illegal water and sewer connections. But now the HC has ruled that no water or sewer connection must be given to such illegal properties." As the court has also directed the state to take action against officials involved in such fraudulent practices, the CMWSSB has formed a team to inspect all 200 wards in the city. The team has classified 1,597 connections in Manali,

Madhavaram, Valasaravakkam, Alandur, Perungudi, and Sholinganallur as illegal, the officer said.

Another official said, "CMWSSB is undertaking water and sewer connection projects worth ₹1,500 crore in newly added areas. Even in these places, numerous complaints have been raised. Some residents have sought water connection using fake revenue documents like 'patta.' We are working with revenue officials

to verify these documents."

The official said, going forward, the agency will not condone such illegal connections. The CMWSSB has issued stringent instructions to its engineers. They are now required to conduct thorough inspections of consumers' addresses and revenue documents to detect encroachments. New water connections will be given only after obtaining a 'No Objection Certificate' from the area engineer concerned.

Tech glitch hits Metro services for two hours

TRAVEL plans of commuters taking metro trains to Chennai Airport on Thursday morning went awry after services were hit for nearly two hours due to a technical glitch.

Services between Alandur Metro Station to Chennai Airport got hit around 8.35am. Initially, single line operation was undertaken from Little Mount to Arignar Anna Alandur Metro. Normal services were operated from Wimco Nagar Depot to Little Mount on the Blue

Line as well as Chennai Central to Alandur Metro Station. Services from St Thomas Mount to Chennai Airport were stopped from 09.32am to help CMRL undertake work to fix the technical glitch.

After a few hours, metro train services resumed between Wimco Nagar Depot and Airport on the Blue Line. The technical issue between Little Mount and Airport has now been resolved. Metro train services on Green Line are being operated as per schedule, Chennai Metro said in a statement.

Kovai corpn wants to maintain Siruvani dam

THE Coimbatore City Municipal Corporation (CCMC) council on Thursday passed a resolution proposing to take over maintenance of Siruvani Dam, treatment plant and water supply works from the Tamil Nadu Water Supply and Drainage (TWAD) Board. This was among the 48 resolutions passed by the council.

CCMC commissioner M Prathap said, "In order to get funds from World Bank, the mainte-

nance and water supply from Siruvani dam was handed over to TWAD Board for a period 20 years in 1984. Although the contract got over in 2004, TWAD board has not yet handed over the maintenance and other works to CCMC."

By taking over the project, Prathap said, the CCMC can treat and supply water to the city at much lesser cost. "The TWAD has been charging ₹11.5 for every litre of water supplied to corporation areas. As of May 2023, TWAD board sent a bill of ₹334.10 crore to CCMC,

of which around ₹106.94 crore has been paid. By taking over maintenance work from TWAD board, we can save around ₹2 to 3 crore per month in water bill," Prathap explained. The resolution proposes taking over all assets linked to the Siruvani dam water supply and waiving off charges since CCMC had executed the project using its resources. Prathap said CCMC could enter into agreements with local bodies to which Siruvani water is supplied and charge them a fee.
